


How to access your CIMC Certificate





In this course, you will learn the process of child informed work, from the ground up. We'll discuss the background and evidence base for child inclusion in family law mediation and counselling contexts, its intent and theoretical rationale (Units 1 and 2). We'll cover methods for assessing appropriateness for the work, and for forming the cross-disciplinary partnerships that best support the work (Units 3 & 4). Unit 5 gives the developmental and theoretical framework for the child interview, and illustrates many tools for helping children of all ages and circumstances to tell their separation story, in a brief, safe, supportive space. Unit 6 teaches you how to transform the children's material into something digestible and useful for parents, something they can think about, and not react to, something they can import into their decision making to fundamentally influence how they will go about finding the higher ground, as separated co-parents. The dialogue we build with parents in this approach is the art and science of the work. You'll see the dispute resolution process itself transform when it's had a child informed beginning. In Unit 7, we will talk about applications of child inclusive work beyond this feedback conversation, how an effective conversation can become a new statement of intent from parents, and how to work it all into a mediation agreement, or parenting plan. We'll consider different models of child inclusive work, and different service contexts. Throughout the program, many illustrations are given, via cases and filmed demonstrations. Within the confines of an online program, you will have many chances to try out new ideas, and expand up your skill set.
